With the advent of the Licensed Site Remediation Professional program in 2009, a whole different paradigm for site remediation evolved. In lieu of requiring the NJDEP approval for every phase of cleaning up contaminated sites, the LSRP was given the authority to perform the studies and the remediation as well as to declare the site as having been satisfactorily cleaned up, all without NJDEP oversight for most contaminated sites in New Jersey.

The Site Remediation Reform Act (SRRA) not only affects potentially responsible parties, local government officials, property purchasers and developers, but all those professionals involved in remediating and developing sites in New Jersey. **This half-day course** is designed to discuss the significant responsibilities associated with the SRRA law and will focus on those individuals who have not been routinely involved in LSRP matters, but now find themselves being able to benefit from this program!
